### **DESCRIPTION OF THE WORKSHOP:**

This is an intermediate-advanced course addressing the complexities of boundary issues in Psychotherapy, and the basic ethical issues regarding tele-mental health. The course will differentiate Between boundary crossing and boundary violation and discuss issues, such as self-disclosure, gifts, physical touch, home visits, bartering, home office, therapy outside the office, and multiple relationships. The importance of informed consent will be emphasized. It will also discuss digital ethics concerns, such as practicing across state lines, use of Skype in therapy, responding to negative Yelp reviews, as well as the use of e-mail, texting in therapy and other issues about tele-mental health. This unique course will incorporate popular movie clips to highlight context-based applications of the therapeutic boundaries. It also emphasizes that flexible therapeutic boundaries and the practice of ethical risk-management can enhance therapeutic alliances and clinical outcomes.

### **Educational Objectives:**

**This course will teach psychotherapists to:**

1. Define and differentiate between boundary crossings, boundary violations, and dual relationships in psychotherapy.

2. Understand the ethical complexities regarding issues, such as gifts, physical touch, self-disclosure, bartering, home visits, therapy outside the office and home office.
3. Describe the complexities and types of risk management practices and cite the relationships between risk management and the standard of care.
4. Identify the ethical and clinical challenges and complexities that arise from participating in telemental health.
5. Identify the concerns around psychotherapy across state lines and the use of Skype in psychotherapy.
6. Determine the elements of an ethical telehealth practice.
