This is an intermediate-advanced course about the complexities of crossing boundaries in psychotherapy and counseling. This unique workshop will incorporate clips from popular movies to highlight expanding contemporary research and literature demonstrating the importance of context-based applications of therapeutic boundaries. It also emphasizes that flexible therapeutic boundaries can enhance therapeutic alliance and clinical outcome.

The workshop will explore the complexities of therapeutic boundaries, such as self-disclosure, gifts, touch, home visits, confidentiality, interventions outside the office, e-mail, texting and Internet issues, multiple clients and multiple loyalties, and much more. It discusses the effect of modern technologies and the Internet on psychotherapy, clinical assessments and counseling.

**OBJECTIVES:** As a result of attending this training, participants should be able to:

1. Utilize sound, ethical decisions in regard to the implementation of non-sexual, non-exploitative boundary crossings.
2. Define and identify boundary crossings, boundary violations and dual relationships.
3. Apply interventions based on clinical rationales, and knowledge of the law and ethics.
4. Design sound clinical records concerning boundary crossings and dual relationships.
5. Integrate boundary crossings into their treatment planning.
6. Review current standards of practice, codes of ethics, and CA law in regard to boundaries in therapy.
